

## Nutana Curling Club return to play 2021 -2022

September 19, 2021

Effective October 1, 2021, the Nutana Curling Club requires all curlers, spectators, volunteers, members and patrons of the restaurant or lounge to be fully vaccinated against COVID-19 (defined as having a second dose of a two dose vaccine or one dose of a single dose vaccine) if they are 12 years of age or older to enter the building for the 2021-2022 Curling Season. Those with a legitimate medical exemption can provide a doctor certified note to the Nutana Curling Club for consideration in replacement of the proof of vaccination. Anyone who can not provide proof of vaccination when requested by the Nutana Curling Club will not be permitted in the building.

### NO OTHER EXEMPTIONS WILL BE GRANTED OTHER THAN MEDICAL

To follow with the Saskatchewan Public Health Order, effective September 16, 2021, anyone who enters the Nutana Curling Club must wear a mask. Masks are mandatory in all parts of the building. Masks may be removed when eating or drinking at a table. Masks are also OPTIONAL while curling in the ice area. Please wear a mask while curling if you feel comfortable doing so.

All policies may be amended when/if any public health orders are changed or added.

Nutana Curling Club will follow all of the guidelines set out by SHA for restaurants/bars in our entire building excluding the ice area.

All of the curling rules will be normal as we all have known them pre covid.

### ENHANCED SANITIZATION

- Deep cleaning and disinfecting methods in the club will continue to be executed each day.
- All staff will be equipped with spray bottles for consistent cleaning of every frequently used surface with properly graded disinfectant.
- Hand sanitizing stations will be located at the entrance of and throughout the club for curler and staff use.
- Rental equipment will be sanitized after every use, however, we do encourage all curlers to purchase their own.

If the SHA requires that the Nutana Curling Club be shut down due to Covid - 19 this season, the following refund policy will be used:

1. If the 2021-22 season never begins or transpires then curlers will be provided the option of a 100% refund of league fees or a credit toward next curling season.
2. If the 2021-22 season is cut short within the first 1 – 5 games then curlers will be provided the option of a 75% refund of league fees or a credit toward next curling season.
3. If the 2021-22 season is cut short within the first 6 – 10 games then curlers will be provided the option of a 50% refund of league fees or a credit toward next curling season.
4. If the 2021-22 season is cut short within the first 11 – 14 games then curlers will be provided the option of a 25% refund of league fees or a credit toward next curling season.
5. If the 2021-22 season is cut short at or after 15 games then there will be no refund provided.

*Interruptions: if the Nutana Curling Club is required to close temporarily because of SHA requirements then every reasonable effort will be made to ensure that make-up games can be rescheduled during the 2021-22 season's timeframe.*

*Administration fee: all refund transactions will be subject to a \$20 administration fee to help cover the credit card fees and administrative labor.*

With respect to the Nutana Curling Club's refund policy, it may be important to point out that the Nutana Curling Club's policy is crafted in such a way to both protect our curler's financial interests and to ensure that the Nutana Curling Club is sufficiently viable to offer its curlers a facility in subsequent seasons.
